The renewal fee is € 26.00 and payment should be made in cash and not Postal Order to the Chief Passport Officer. The space next to this one should read as follows:

“Where all available space on a Passport is already occupied by visas, application must be made on Form C1 for the issue of a New Passport, and the full fee of € 77.00 is chargeable”.

The maximum life of a Passport is 10 years from the date of initial issue.

(a) Christian names and Surname in full. (Surname in Block Capitals).

(b) Insert number of years (not exceeding five) for which it is desired the passport shall be renewed, provided that the total period of validity of ten years is not exceeded.

Postage stamps will not be accepted in payment.

Passports which have been in existence for ten years or which contain no further space for visas are not renewable, and the holders must apply for the grant of new Passports.

(c) Insert “Citizen of Nigeria”, Citizen of Nigeria by naturalisation”, etc. as the case may be.

(d) Name and qualification of person verifying the Declaration who should himself be a Citizen of Nigeria viz:-

Government Official, Banker, Minister of Religion, Barrister-at-Law, Physician, Surgeon, Solicitor, or other responsible person, giving professional address.

Recommendations from members or officials of *Banking Firms* should bear the printed stamp of the Bank here below.
